Although the specific nature of the specific nature of children's maintenance differs from State to another, the basic principle of child maintenance is the same all jurisdictions. This may involve talking to the child independently, which often happens first to avoid the possibility of a caregiver forcing the child to lie or withhold information. The assumption here is that the parent who has custody is spending all of their income on raising the child, so the parent who does not have custody needs to help. The main goal is to keep a child out of harm's way by eliminating immediate threats and then assessing the risk of continued abuse or neglect. A also keep in mind that officers have a legal obligation to follow up on a report, even a false one; therefore, instead of responding to a visit with anger, the best way to act is to help with the investigation as much as possible to quickly prove that there is no neglect or abuse. A six-step process is used to review the child's primary support needs, such as education and medical bills, child care expenses, and then the child's extra medical expenses. During the investigation, officers may try to prove or disprove the allegations and question the relevant parties thoroughly. While there may be occasional exceptions, when the report is deemed not to highlight a case of negligence or abuse, most investigations are initiated within 24 to 72 hours. However, because abuse cases are criminal in nature, CPS officers may seek the assistance of law enforcement officers, whose primary function is the criminal process related to the abuser's arrest. Why is there CPS in my state? Each U.S. state has a department dedicated to child protection, but that department is not always referred to as Child Protection Services.
